To organize and empower the rural poor to promote development as a liberating force for achieving social justice, economic growth and self reliance.

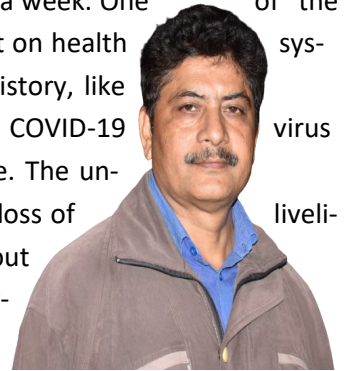
### **Objectives:**

## FROM THE DESK OF EXECUTIVE DIRECTOR

History will not forget the March of 2020 and how the world changed in the matter of a week. One of the biggest global crises in generations, the COVID-19 pandemic has had unforeseen effect on health systems, economies and societies. Although there have been few epidemics in recent history, like 2002-04 SARS outbreak and the Ebola epidemic in Africa, The speed with which the COVID-19 virus infected the world is not comparable. Over five & half million people died worldwide. The unprecedented lockdown had disproportionately hurt marginalized communities due to loss of livelihood and lack of food, health, and other basic needs. Children and youth have missed out on learning and socializing. It has adversely affected lakhs of daily wage earners, servants, construction workers, daily labourers, Rickshaw-pullers, Hotel boy, barber, dhobi, farmers and so on. These marginalized families faced hunger as they didn't have any means of income to feed their families and the unemployment, lack of livelihood opportunity still prevail. SATRA tried to stand by the underprivileged & under resourced families at the hour of crisis by providing dry ration, unconditional cash transfer, livelihood support and medical assistance. Despite all the odds, SATRA as a team learned a lot, when all the people were under lockdown the volunteers of SATRA as a frontline worker got the opportunity to work for the vulnerable people. SATRA reached out to around 20,000 families in Darrang & Udalguri district. I must mention here and appreciate the afford made by agencies, donors and our partners to reach out to the needy people. Azim Premji Philanthropic Initiatives, tdh Germany, Bread for the world and many other came forward to support our community during the crisis. With support from Azim Premji Foundation, SATRA in collaboration with NHM and Health & Family Welfare department Govt.of Assam organised COVID 19 vaccination camps in remote & most vaccine resistance places of Udalguri district. I applaud the hard work & sincerity of our team for which we were able to administered around 60000 jabs in five months in the most unreachable Adivasi & Bodo villages of Udalguri district. Apart from COVID 19 challenges, Mental Health problem has increased by around 25% after COVID-19. A number of people have reported psychological distress and symptoms of anxiety, depression, or post-traumatic stress etc. Most worrying fact is that suicidal thoughts and behaviours has increased after COVID-19. Presently the community mental health program is the most relevant program considering the current data and statistics of mental health. SATRA aspires to extend the community mental health program to the adjacent district Udalguri and to Arunachal Pradesh in next two years. Moving down from health SATRA's strategic planning calls for a sustainable environment & livelihood. Intervention shall be intense to produce ecologically sustainable, nutritious, ethical and safe food to promote human and environmental health. Today global food production is associated with 15% of global greenhouse gas emissions and the projections show that feeding a world population of 9 billion people in 2050 would require raising overall food production by some 70%. The sustainable approach to food production will increase agricultural production, reduce greenhouse gas emissions and ensure responsible consumption.



I take this opportunity to express our sincere thanks & deep gratitude to Azim Premji Philanthropic Initiatives, tdh Germany, Bread for the world, CASA, Habitat for Humanity, Action Aid Association, and Breath for India for supporting during crisis. I am deeply grateful to our Chairman Dr. Prasanna Kumar Nath and the executive board for their guidance, support & suggestion. Lastly, my thanks are due to my colleagues in the SATRA family for putting up the Incredible team spirit, dedication & hard work.

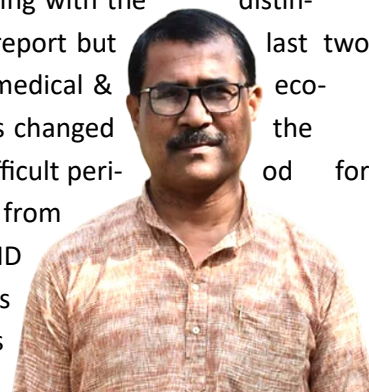

## FROM THE DESK OF CHAIRMAN

It has been my privilege to be chairperson of SATRA. I learned and enjoyed working with the distinguished board members and SATRA staff. It is always a joy to write the annual report but last two years were so distressing with uncertainty and a lot of challenges to deal with medical & economic emergencies due to COVID. The unprecedented outbreak of COVID-19 has changed the world. It has affected every sector so as the NGO. COVID period were the most difficult period for any sector. Hopefully, COVID is gone and the growth of the NGO sector recovers from COVID impact. Let's hope and pray that COVID never happens again. After COVID the awareness of the environment and regenerative & sustainable agriculture has significantly increased. It is expected that there will be more fund flow for NGOs of North East India under Corporate Social Responsibility. Corporates and other funders are expected to support health and mental health. NGOs are the driving force for the development of society, economy, education, health, and other social issues. Looking back closely at the SATRA's journey of two decades I can say despite many challenges, limitations, ups & down, we have been able to establish a good rapport among the marginalized, under-resourced families of Darrang and Udalguri districts. SATAR has been focusing on creating a sustainable and economically secure society by ensuring no gender discrimination, promotion of sustainable livelihood, protection of child rights, protection of mental health & promotion of mental health well-being. Resource management, Environment conservation, and climate-smart agriculture will get priority in the next 3 years. Every member of the SATRA family is conscious of the task at hand. I strongly believe that together we can face the future with confidence and optimism. The riverine areas (island) of the river Brahmaputra in Darrang District, locally called *Char Chapori* are extremely backward and at the forefront of climate disasters such as flooding due to excessive rainfall and destruction of crops due to soil erosion. Poverty & unequal gender norms restrict access to resources, education, information, employment, and income, which significantly impacts the health, knowledge & behaviors of people. The social structure of the Char areas of Assam is influenced by a patriarchal social order that strictly regulates gender roles. With no other income source, the men resort to migration to work as unskilled laborers in big cities. Women and girls are additionally marginalized bearing the brunt of extreme poverty and the existence of patriarchy, this is evident through such indicators – poor health, especially reproductive health, child marriage & early marriage as well as early motherhood and non-institutional delivery of babies. The intervention has to be made for the social & economic development of the society. The capacity of the dwellers has to be made on climate-smart agriculture as cultivation is the primary source of income for the families.



I would like to gratefully acknowledge the support of Darrang district administration, Azim Premji Philanthropic Initiatives, Oxfam (India), Tdh Germany, Bread for the world, CASA & all our well-wishers. I appreciate your continued support of the endeavors of SATRA. I take this opportunity to thank all our generous and loving donors and supporter. # Community Mental Health & Empowering Persons With Disability



SATRA implemented a Community Mental Health Programme, supported by Azim Premji Philanthropic Initiatives, with the objectives of “De-stigmatization & De-Mystify mental health in the community”. The program focused on creating a social acceptance of mental health & mental illness. The community is able to seek help from mental health specialists breaking the barriers of stigma and traditional healing practices. The following are the program components:

## COMPONENTS:-

1. Patient identification.
2. Caregivers training.
3. Awareness campaign in the community.
4. Treatment & Psycho-Education
5. Formation of the village-level committee.
6. Follow-up.
7. Livelihood support.
8. Support group formation.
9. Promotion of nonmedico para mental health worker at village level

Following are the activity undertaken in the program:

- ♦ Awareness in School, college and community: Awareness was done using innovative method.
- ♦ Organize mental health screening camps and facilitate treatment in the Government hospital especially for the persons with mental illness.
- ♦ Caregiver training and counseling: Care giver would mostly be the close family members. They are also most vulnerable as mostly they have to look after Persons with mental illness.

- ♦ Organize camps for disability certification.
- ♦ Support group formation.
- ♦ Skill development training and livelihood support.
- ♦ Linkage with the financial institution and other government scheme.
- ♦ Training to selected persons for entrepreneurship development.
- ♦ Support for out-of-school disable children.

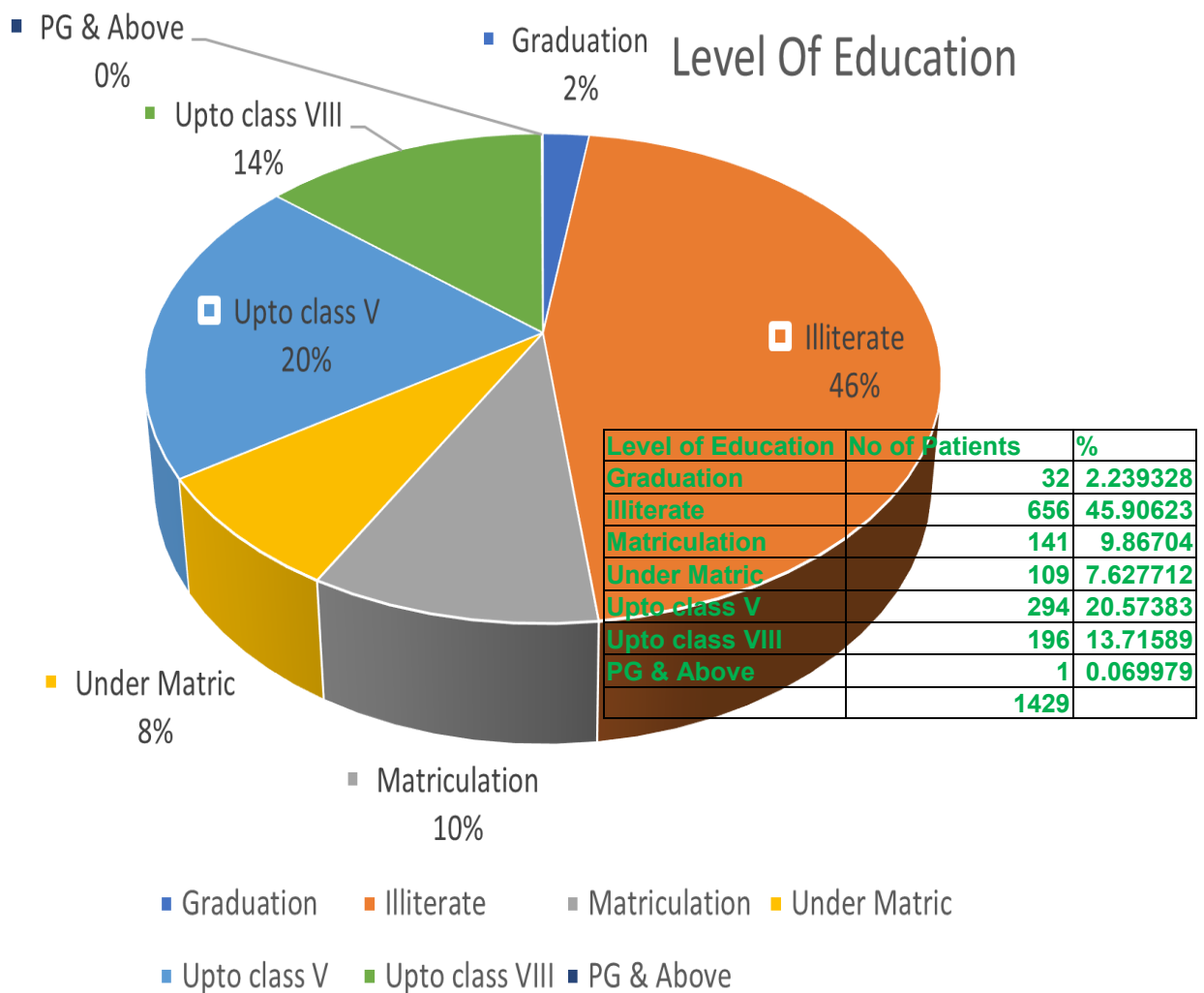
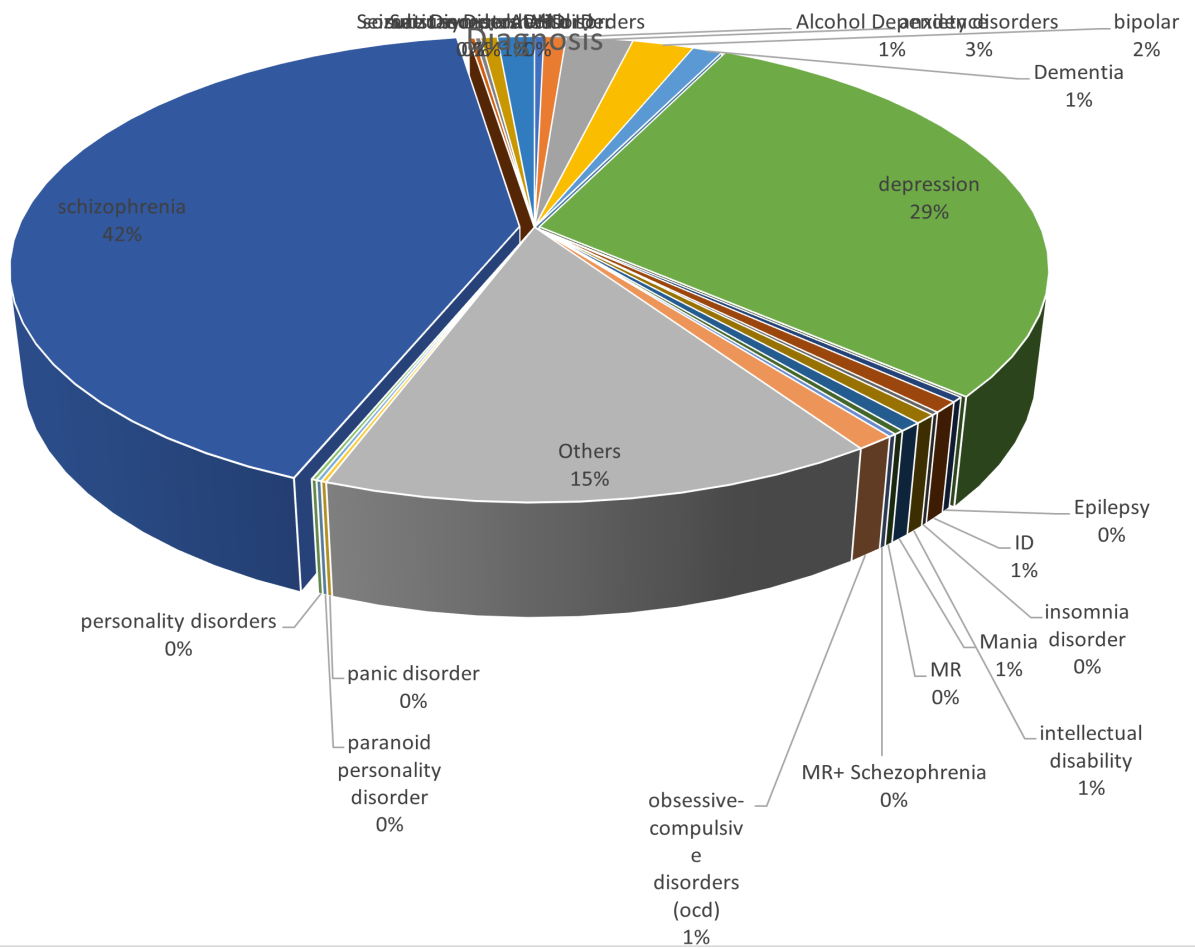

- **Primary objectives were to reduce social stigma attached with mental health & mental illness. Stigma. identify people with mental illness and disabilities and bring them for treatment provide assistance in getting the disability certificate and liaison with the government for advocacy to ensure that they get the basic rights, rehabilitate the children with IDD and other developmental disabilities. Strengthen the community by building their capacities through various training programs to deal effectively with mental health issues, promote the non-specialists in mental health care as there is a lack of mental health professionals in the community.**
- **Provide & promote livelihood support for self-sustenance.**
- **The village committees were formed for each community with Anganwadi, village headmen, ASHA workers and other prominent and influential people. This committee helped in identifying, reporting and motivating people with mental illness to seek treatment**

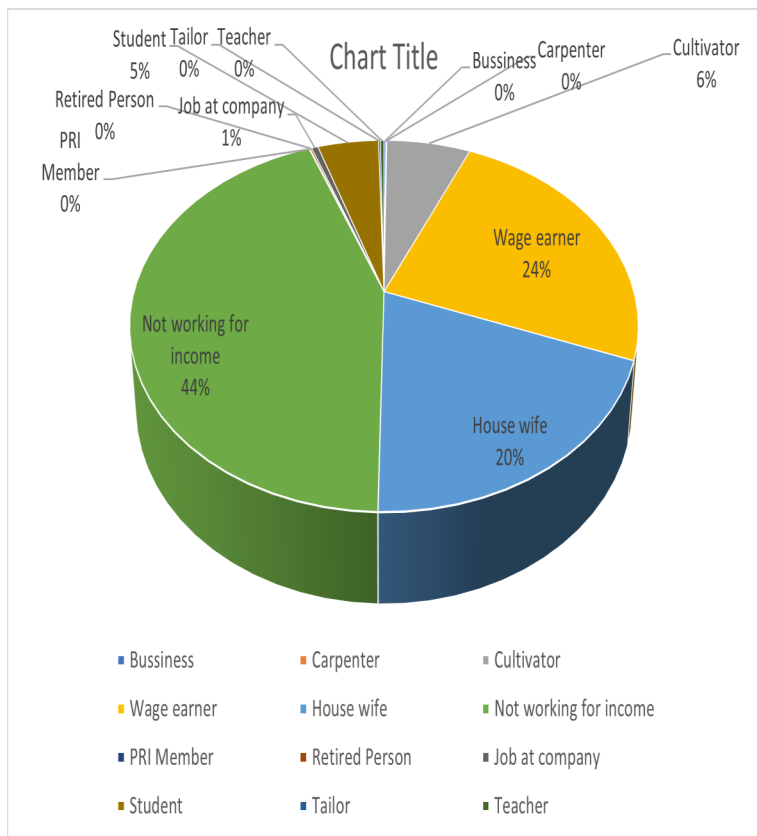
#### **Project Outcome:**

## Case Story

**Weaver: Mrs. XYZ**

Mrs. Runu Baruah a widow & mother of four daughters, three daughters are married and the youngest one is 14 years of age living with her. Her husband was a carpenter, died in an accident in the year 2017. During the construction of a house, he fell down from the roof and died before reaching hospital. Mrs. XYZ was shocked and had severe Post Traumatic Stress Disorder (PTSD) for some time gradually got rid of the situation and was somehow managing the family expenses by rearing cattle and selling little milk produces in the home. During the COVID lockdown, it was very difficult for her to manage two squares of meals for herself & her daughter. She could not sleep for three/four days together, didn't feel like eating anything, had the suicidal tendency, self-murmuring, and was always angry. In the month of May 2021. SATRAs Community Organizer identified her and brought to the mental health camp. She was diagnosed as having major depression. Besides medicine, psychosocial support was given to the family, did an awareness meeting with neighbours and motivate all to support her for stigma-free mental health & mental illness. In 3 months, her condition was improved. In March 2022 she was selected for livelihood support, as she knew weaving she was given training on weaving Eri-Silk. The silkworm rearing & weaving of silk are part of tradition & culture in Assam. The Eri silk is also called non-violent silk as it can be processed without killing the silkworm. She was given the handloom



set, training on weaving and natural dye, etc. Now she is weaving naturally dyed Eri Silk shawl & scarf. Support her to De-Stigmatize mental health & mental illness. She is now quite confident that she would be able to manage her family. She got Rs. 8000 by selling Eri cloth she weaved. She is happy now. She said " I will work hard to see my youngest daughter do a higher study" She continue "I am so grateful to SATRA for conducting mental health camps else I wouldn't have live till now, thank you so much"



# Biodiversity & Climate Change Adaptation



One of the major areas of intervention for SATRA has been biodiversity conservation and climate change mitigation and adaptation. SATRA's work in biodiversity and climate change has been instrumental in promoting sustainable development in rural areas. By focusing on sustainable agriculture practices, awareness-raising, and advocacy, SATRA has been able to promote environmental conservation and sustainable livelihoods for rural communities.

SATRA's interventions in biodiversity conservation and climate change are aimed at promoting sustainable livelihoods of the local communities while also conserving natural resources. The organization has been involved in a range of activities, including:

## Livelihood & Climate Adaption

Climate change has affected farmers in rural areas. Their livelihoods are very dependent on the climate so their socio-economic life becomes vulnerable. Climate change causes the level of vulnerability to livelihood to be higher.

# Project: Strengthening Community Action for development in North East India

## Supported By: Bread for the World

**Village level meeting on information sharing:** SATRA explained purpose of the project in 15 project villages and through the project what outcome to be captured as a result of project activities.

**CBO. PIO Leaders training:** During this reporting period we are trained in Village Rights Committee (CBO) as well as Jana Jagaran Adhikar Samittee (PO) members already constituted in our project.

**Linkage with Govt. Line Department:** SATRA personnel with PO member visit maximum department to know the criteria for availing support to community

**Awareness programme on livelihood scheme in various department:** SATRA do awareness meeting at project villages about various govt. flagship programme and scheme. Where CBO members, SHG members and village leaders participate in the awareness meeting.

**Skill development training to farmers:** About 100 selected farmers are selected for banana cultivation by SATRA under this programme. These farmers are already given various trainings through workshops on bananas and 20 tissue plants are provided to them.

**Support to selected farmers of organic manure:** 20 selected farmers are trained to make vermin compost to make compost with local and household items with the help of KVK scientists.

**Demonstration of New Livelihood option:** 7 selected farmers are selected for bee keeping by SATRA under this programme. These farmers are already given various trainings through workshops on bee keeping and 1 Honey box with Colony are provided to each farmers.

**Linkage meeting:** Meanwhile SATRA signed an agreement with Assam State Livelihood mission with consent of both the parties. It will enable contribution to rural economy through enhancing the skill of Self Help Groups in the project villages. On the other hand, Preliminary work has already stated with the aim of setting up a FPO by connecting farmers who want to observe honey through the honey bee mission being carried out through the agriculture department of the Assam government. Talks have been initiated with the agriculture department for the said. However work has been started with 7 selected farmers.



**Technical Training for selected farmers:** About 100 selected farmers are selected for banana cultivation by SATRA under this programme. These farmers are already given various trainings on bananas and 20 tissue plants are provided to each farmer.

**Workshop on Gender mainstreaming:** SATRA have policy on gender mainstreaming. So, we always see it. Gender specific interventions can target women exclusively, men and women together or only men to enable them to participate in and benefit equally from development efforts.

**Awareness campaign on Gender mainstreaming:** In every village we conducted awareness meeting on gender main-



streaming where SHG, PRI members and local CBO members are participated positively.

**Community participation to improve ICDS/ VHSND programme:** SATRA supported some of the VHSND in different places in Darrang district for smoothly conducted VHSND as well as RI programme in village level. The objectives of these supporting were to come forward in this pandemic with their full confidence. Because ASHA, ANM, AWW, PRI member, village head were assemble in VHSND and they are the grassroots fighter against COVID 19 virus. On the other hand to empower community-based institution to increase vaccine confidence and routine immunization demand and prevention of COVID 19 through promotion of key practices at the community level.

**Capacity building of POs, youth, CBO leaders, PRIs, Volunteers on covid appropriate behavior:** We capacitate about Covid Appropriate Behavior (CAB) in different level of Society through social media, physical meet, awareness meeting. In this activity our targeted participant are SATRA staff & volunteer, PRI member, existing village CBO, everyone's presents is noticed as we think.

**Awareness Campaign about CAB Home quarantine procedures, isolation procedures, dos and don'ts. Health workers, PRIs, ASHA workers, Volunteers, youth and PO leaders:** In this period we aware about Covid Appropriate Behavior (CAB) home quarantine procedures, isolation procedures, dos and don'ts. Health workers, PRIs, ASHA workers, Volunteers, youth and PO leaders in different places with support from district immunization officer Dr. Aswini Kumar Dhing. He was very supportive to our work.

**Provision of ration to affected families:** In this reporting period about 2000 people were infected with the covid virus in the district apart from our project village. We did not have a special scheme to help most vulnerable family but in an incredible way we were able to help with some donors. We provide one month dry food ration to poorest of the poor covid affected families in our project villages by selecting 10 families. Where there were items like Sugar, Tea, Dall, M-oil, Potato, Onion, Soyabari, Salt, Soap etc.

**Support to local CHC/ PHC supplying essential needs:** We are provided with some Clinical mask, hand sanitizer, Thermometer and Oxeemeter in our local CHC.

**Livelihood support to affected and seed support to families:** SATRA distributed seeds of Robi crops 62 Covid affected family. Where mustards. Brinjal, been, carrots, chilly, Ly, Paleng etc.

**Leveraging resources from Govt Covid related schemes and programmes, Lisoning with health department at all level :**

In this activity Thermometer and Oxeemeter provided our village CBO Goan Adhikar Samitee and PO Jana Jagaran Adhikar Samittee. During the second wave of covid SATRA did the awareness campaign through various social media platform, organize two special vaccination camp in Sipajhar and in Bhakatpara. SATRA in collaboration with District Child Protection Unit, Childline 1098 emergency service of Darrang Udalguri. A voluntary group of psychiatrist & psychologist were formed to provide psycho education support to the person who is depressed during covid. During this period SATRA has taken step to address the problem of the community through POs monthly meeting.

The PO (Jana Jagaran Adhikar Sangha) formed under our programme has been holding monthly meetings on the first saturday of every month. However the partial lockdown of the State and the outbreak of the Corona and delta variant Omicron epidemic were put on hold as the outbreak increased.

Every PO member takes the lead in visiting families in their respective villages to make them aware of the Covid Appropriate Behaviour (CAB).

For PO advocacy, community received training as well as seed support in collaboration with The Agriculture Department, Veterinary Department, KVK, Fishery, Handloom Department.

Mask and sanitizer distribution for Covid affected families in our program Village. We disseminate the key messages in the community to prevent COVID 19, Omicron how to communicate with people outside and in the home, ways of hand washing with soap, role and responsibility of individuals and CSO in managing and helping quarantine people/ family, role and responsibility of all to work against the stigma attached to COVID 19 etc through social media like messaging, WGCAN portal (Messaging Andriod App), whatsapp group, facebook and also phone call.



# COVID Vaccination Program



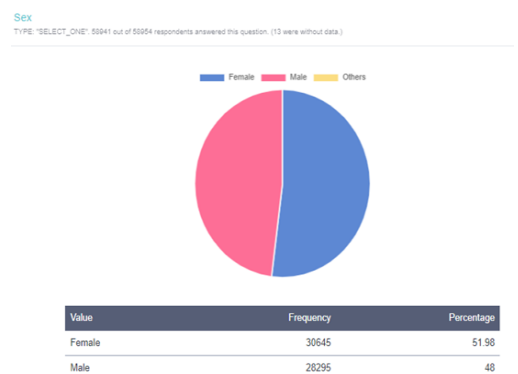
**Introduction:** The Udalguri district comes under Bodoland Territorial Region (BTR), bounded by Bhutan and Arunachal Pradesh in the north, Sonitpur district in the east, Darrang district in the south and Baksa district in the west. The District has three health Block Udalguri, Khairabari & Orang. After long discussion with the Joint Director health & family welfare Udalguri, Senior health officials & Block Program Manager NHM, Udalguri. It was decided to work in Udalguri health block for 100% COVID vaccination of the eligible population with both the doses. The vaccination program started from 1<sup>st</sup> of November 2021 & ended on 31<sup>st</sup> March 2022. The Udalguri health block is the largest health block in Assam with 347 villages and has the most Covid vaccine-resistant population.

## Project Information:

- ◆ Out of 12 Health sector under the Udalguri BPHC there are six sectors that had the most resistance and hesitancy.
- ◆ The inhabitants are Bodo, Adivasi, Santhali, Nepali, Garo etc.
- ◆ The district has a Total Population of 873251 Total 18+ population **567613**.
- ◆ The Udalguri health block has a total population of 370000 total 18+ population is 240500.

## The project had the following deliverables & targets:

1. The intense intervention targeted in 66 most vaccine-resistant villages
2. Total Population 54329
3. Total 18+ population 39986
4. Total persons with 1st dose vaccination at the time of intervention 11802 or 30% (Early October)
5. Total target for the 1st dose was **27636**.
6. Target Achieved (1st dose) at the end (31st March): **24605 (89%)**
7. 2nd dose or target: **39636**
8. 2nd dose target achieved: **34349 (89%) (31st March)**
9. Total jabs: **58954**

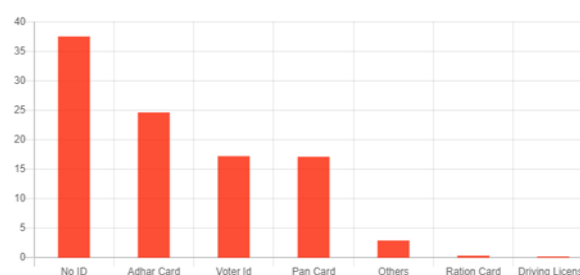
## Reasons for the hesitancy at the time of intervention

- There are tea garden areas and many people are daily wage earners, it cost them a days work. Even if the person takes leave for the vaccination, the proper information was not there on whether he would be able to get the vaccine on the same day or not. If falls sick after the vaccine he would miss two three days wage.
- November December is Paddy harvesting season if get fever after the vaccine he may not be able to harvest for three four days and might lost some paddy.
- There was a rumour that people will die after two years of taking the vaccine.
- Vaccine led to decline in pregnancy rate
- Vaccine causes infertility.
- Vaccine is Business of the Government.
- The most important reason of resistance was the “666” the number of the beast. We also came to know after intervention only.
- Not having any ID proof: Many people in the tea garden areas do not have any identity proof, they even do not ration card also. So they thought it was not possible to get the Vaccination without ID. 37.5% of the people who were vaccinated in the camps we organized were without any ID.

## Processes Followed:

1. Organized 36 village level meetings

2. Most of the hesitancy was for 666 issues. Organised 10 meetings with the Christian religious leaders of District level of each denomination (Note: in the Christian religion, there are many denominations e.g. Baptist, Lutheran, Roman Catholic, CNI (Church of North India) etc.) BBC (Bodo Baptist convention) is the oldest and most influential denomination. 1st meeting with the BBC on 10th Nov attended by Rev. Dr Utpal Moshahary (Executive Secretary, BBC), Mangalsing Hajowary (Development Secretary, BBC), Binoy Daimari (Mission Secretary, BBC). They agreed to issue a circular to all the Churches under BBC to ensure all 18+ get vaccinated. They also agreed to write to all the Pastors to preach on 666 to the believers. Likewise, we held meeting at district level with the leaders of Bodo Evangelical Lutheran Churches, Roman Catholic & CNI. The response from all was very positive. After the Pastors got the letter from the district committee to preach “666” during Sunday Church service and also wrote to ensure that everybody is vaccinated. We held several meetings with the pastors and community leaders and discussed with them how to go ahead and ensure that every body is vaccinated. Surprisingly very few Pastors were vaccinated till they get the letter. Our Community Health Worker & Community Resource Persons motivated people by visiting door to door. We organize vaccination sessions outside or inside the Church campus on Sunday.

**Success story:** 1. In a village called Santipur, on the previous vaccination

session at the sub-center only 4 people turned up this was on Friday. Next Sunday (on 21st Nov) we organized session in the same village near a church and 109 people came for vaccination.

2. Held meeting with the owner of the small tea grower who has 15/20 or even less labour working in the garden. Most of these people didn't have any ID proof. So when owner of the garden motivated them and also informed that its possible to get the vaccination done without ID also. They started coming but after 2pm when the work at the garden is over. So we organize many camps from 1.30 pm.

3. Miking was very effective before & during the vaccination session.

4. Team up with ASHA to identify and line-list vaccine-hesitant individuals. Visit door to door.

**Challenges:** 1. Many ASHA's didn't cooperate at the beginning as they were under threat from the community and regarded them as the Lucifer or Satan who seduces humans into sin or falsehood. 2. Lots of threats to our team as well during "Har Ghar Dastak program" as the government officer forced people to get the vaccination.

3. 2nd dose overdue was a concern as much as 51045 people are overdue as of 27th January. Our team Collected the list from health department and contacted all the drop out over phone and also did home visit

# Women Livelihood: Weaving



Weaving is a subsidiary activity to farming, done by women during their spare time. The rhythm of handloom could be heard in every villages of Assam but the earning out of it was very minimal. The women mostly produced cloth for their own consumption. The minimum commercial production was based traditional skills poor women weaved plain shawl, scarf, dress materials and Endi shawl. There are women weavers for whom weaving is a way of life but the majority of handloom weavers followed the hereditary line. The weavers have no marketing linkage or do not have the knowledge of the saleable product in the national or global market. It was observed that the activity in the area were declining in the late nineties. SATRA intervened with little handholding support including skill upgradation, transfer of better technology to weavers, design development according to the market trend, motivating the weavers to adopt the same and also help in providing better access to market for the products, so that their productivity, quality and earnings could be enhanced. With this intervention was expected that this could be a sustainable source of livelihood for the poor families. The activity is going on in 90 village of Darrang & Udalguri district with 440 active weavers. The weavers are producing: Cotton Gamosa , Pat Gamosa , Pat Stole , Eri Stole , Eri Swale , Eri Endi , Eri Than , Cotton than , Cotton Sadar Mekhela , Pat sadar Mekhela , Pat Than , Extra Sadar , extra mekhela etc. As of now average income by one weaver is Rs. 2500.00

On the occasion of world environment day 2021 on 5<sup>th</sup> June children from nearby villages gathered in SATRA's office and performed in various events like drawing, drama & singing with the message to develop a sense of respect and care for the natural environment.

The NGO's and CBO's those were trained under the capacity building program areas working in the respective areas to create mass awareness and bring the LODOR families to RI session. And out of 63 total 59 LODOR child brought under the program.

### **Community Consultation (Religious leader, CBO members).**

Engagement of influencers produced some very good productive results from the beginning of the project. The announcement from Mazid particularly and the awareness program with religious leader like moulana convinced many LODOR families.

### **Hand Washing**

Observed global hand washing day on 12th Oct. to 16 Oct. in 12 places the awareness was created with small group of children and parents and the message of immunization was disseminated in during hand washing hygiene campaign. All the LODOR families were visited personally with religious leader, Influencers and village leading person to bring them in the program, which produced some good result.

### **Influencers**

Influencers are playing vital role in our projected areas, after orientation they are competent to convince all the people. During orientation all the influencers agreed to take the issues seriously and they will create awareness among the LODOR families and as a whole for motivating people for ensuring vaccination and immunization.

### **Using Religious platform.**

Engagement of influencers produced some very good productive results from the beginning of the project. The announcement from Mazid particularly and the awareness program with religious leader like moulana convinced many LODOR families.

### **COVID-19**

SATRA have a whatsapp group and a facebook group where influencers are disseminated the key message regarding COVID-19 do's & don'ts and other routine immunization. Also we have a message dissemination portal namely "WGCAN" where we disseminated messages.

## **Challenges faced and their mitigation**

Rumors among local people of char area where they believe vaccination led to impotency.  
Migration of people from one place to another due to environmental issue like soil erosion, flood etc or better life opportunity.  
Lack of awareness about the vaccination drive.  
Lack of roads and due to bad transportations govt officials skip the place for their vaccination drive .

## **Way forward**

Using local influencer like religious leaders, teachers to educate people about the benefit and eradicating the rumors  
Doing surveys to find out numbers of people who were LODORs  
Setting up special vaccination camps for LODORs  
Facilitating and advocating govt officials to visit places that are not reachable.  
Creating awareness using the local CBO or SHG.

## **Potential role in promotion of COVID-19 vaccine uptake from March onwards.**

Providing govt officials with the list of old/disable person who cannot visit far away covid vaccination centre  
Advocating the govt officials to set up special camps for old/disable persons  
Creating awareness and eradication rumors through local CBO  
Holding programs to educate people about the post vaccination routine  
Ensuring people are back for the second dose after 28 days



# World Mental Health Day 2021

Some groups, including health and other front-line workers, students, people living alone, and those with pre-existing mental health conditions, have been particularly affected. And services for mental, neurological and substance use disorders have been significantly disrupted. World Mental Health Day is celebrated across the world 10<sup>th</sup> October every year.

On the occasion of World Mental Health Day 2021, SATRA organized a 5 km walkathon among the patients and care giver, altogether 58 patients and 17 care giver participated in the walkathon to create awareness on the Mental Health particularly on the theme of the World Mental Health Day 2021 "Mental Health care for all: let's make it a reality" all the participants were invited for the lunch. In the afternoon we organized a mass awareness campaign in twitter from 4:30pm which we called Tweetathon. We have provided the with three links with following message asked tweeter user to retweet the following message more than 5000 then tweets got 5000 impression.

Access to mental health services remains unequal with between 75% to 95 % people with mental illness in low- and middle income countries unable to access mental health services at all.

Lack of investment in mental health disproportionate to the overall health budget contributes to mental health treatment gape

Let's come together to create a world where there is mental health equity, equality and social justice for all.

Let's join hands to De-Stigmatize & De-Mystify Mental health & Mental illness in the society. Stigma is big barrier in seeking treatment.





## DIGITAL LEARNING through Chimple App.

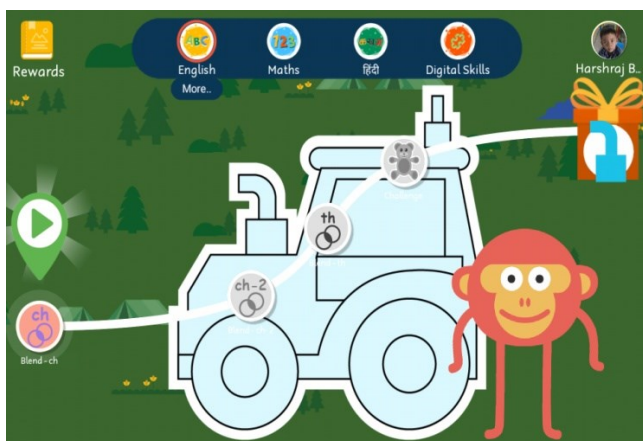
The project DIGITAL PLATFORM FOR LEARNING USING CHIMPLE has been implementing by SATRA with support under CSR from NORTH EAST NUTRIENTS PVT LIMITED. Through this intervention, it is expected to uplift the basic education of children aged 5 and 6 using an app "CHIMPLE".

SATRA has selected 500 students from 5 schools belonging to classes 1 and 2 and distributed 100 tablets and accessories like Headphones and back cover with ratio 5:1 per students to the Schools namely Ramhari LP School , Ghorabandha LP School, Mangaldai balak lp school, Saloipara LP School, Chandowalpara LP School . The wireless internet connection was also installed in all 5 school.



The core objective of the project is to bring digital joyful learning experience to the most basic level. Technology partner, Sutara learning foundation Bengaluru provided with the Chimple App. It has an excellent track record of providing joyful learning experiences. According to the reports from Indian express and economic times, a whopping 37.15 % of children uses smartphones, with an average 3 hours daily screen time to use social media platform. Chimple intends to shift the curiosity of the young minds to more productive genre. ". Chimple employs joyful and creative element in form of game based self-learning thus clicking right in the child's basic instinct. It also encourages positive competition among children.

Through the app, kids learn Math and Science in a fun creative visually stimulating way which helps them understand better instead of the traditional method.



### Activity:

1. The training of teachers has been conducted by SATRA on the usability of the app.
2. Installation of the Chimple App in the Tablet and necessary software modules.

3. Conducted trials classes to eliminate problem and smooth roll out of the project from April 2022.
4. The progress can be tracked through another admin-only app where the details of every student can be checked.

### **Expected Outcome:**

1. Class using the CHIMPLE App to be held for at least an hour every working day.
2. To uplift overall performance for each individual student in term of intelligence, objectivity and ability to understand technology at an early age. The self learning aspect could introduce a sense of responsibility.
3. It is expected to get more than 3000 minutes or 50 hours of activity for each student from all 5 schools for next session 22-23.

Darrang CHILDLINE has intervened 210 cases in the financial year 2021-22, when we see in the table 1.1 we can see that child marriage case in the district is high compared to other case category, the number of



cases shown in the table 1.1 is reported cases through CHILDLINE 1098 services, there may be many more in the district which cases may not be reported.

The mentioned cases in table 1.1 is intervened by Darrang CHILDLINE and produces the cases in the Child Welfare Committee (CWC) of Darrang District, all the child related cases are handle by CWC, CWC is under the District Child Protection Unit and the CWC committee is of 4 members and 1 chairperson, after taking the statement of the victim child all the decision are taken by the CWC committee of a child in need of care and protection as per the Juvenile Justice (Care and Protection of Children) Act, 2015. Darrang CHILDLINE also facilitated to the victim parents in lodging FIR if necessary, in the FY-2021-22 Darrang CHILDLINE have facilitated for lodging FIR to 10 families.

In spite of Pandemic COVID-19 Situation Darrang CHILDLINE try level based to render CHILDLINE 1098 services by maintaining all the COVID-19 protocols, the numbers of awareness programmes, outreach programmes are shown in the table 1.2 and 1.3 below-

The Executive Director of SATRA Sri Nani Kumar Saikia took to the floor to enunciate to the team the purpose of the staff retreats which is to inculcate the values of SATRA and to drive cooperation and nurture interpersonal relationships amongst staff. Later Sr. Program Manager Sri K Z Hoque introduced the team to various interesting team-building activities. Lunch was prepared & served after that team was asked to click photos of different plants & birds and write a sentence.
